OMC HAIRWORLD COMPETITION AWARDS SYSTEM

Senior Titles:

The OMC World Cup & Title is awarded only to senior competitors. The OMC World Cup belongs to the winning organization of the category concerned. However, If the competitors are from different organizations within the country, the world cup goes to the organizations who have the most competitors in the team. Furthermore, if there are 3 organizations, and each organization has one competitor that forms the final team, the OMC world cup goes to the organization whose competitor has most points on the team general classification.

Forbidden to copy the Sr. OMC World Cup:

If an OMC organization or an individual competitor copy the OMC WORLD CUP. OMC will revoke their world champion title and membership.

Junior Title:

OMC INTERNATIONAL JR. RISING STAR TEAM AWARD

The Junior competitors are never to promote themselves to be “Junior World Champions” If this would be the case OMC will revoke their junior title and membership of their organization.

Junior Awards:

OMC INTERNATIONAL JR. RISING STAR TEAM and INDIVIDUAL 1st to 3rd Pl. will receive the Jr. Rising Star Trophy +Diplomas. The 4th 5th 6th places individual or teams will receive the “**OMC HONORAWARD**” All other Jr. competitors will be presented with **OMC Recognition Award**.

OMC GENERAL REGULATIONS:

OMC General Instructions for Competitions: All tests can be entered individually or as a combination. A competitor can register to compete in individual and team tests within the same section. However, country teams will be formed only from national competitors registered in the combination categories.

Registration Conditions: Only OMC-affiliated country individual organizations or individual members current with annual membership dues may participate in OMC International Championships. A competitor can pay directly online during registration. Official country organizations must provide their competitors with the OMC affiliated organizations country code to their competitors. After the registration deadline, OMC will send each country organization a complete list for confirmation. The organization will have **three (3) days** to confirm. If no reply is received within three days, OMC will consider the competitor registration list approved. Registration is open to all member country organizations and individual members who are current with their membership dues. OMC offers membership only to Independent national organizations and professional hair & beauty groups in their concerned countries.

OMC Registration Terms & Conditions: By signing the OMC terms and conditions, competitors automatically agree that their creative work presented on their model or mannequin head in the competition arena, as well as photos submitted in online competitions, become the property and copyright of OMC and OMC HAIRWORLD. OMC, OMC HAIRWORLD, and the host country/fair company shall not be liable for any damage.

OMC Team World Cup: Automatic team selection, the best 3 competitors from a country will automatically form the national team. Only from combinations categories. The OMC Team World Cup is presented to the presidents of country organizations. The three (3) team members will receive the OMC Miniature Team World Cup. If competitors are from different organizations within a country, the team world cup is awarded to the organization with the most competitors on the team. **Other example:** If there are three organizations within a country and each has one competitor forming a team, the world cup goes to the organization whose competitor has the highest team classification points. **(If fewer than 3 teams, OMC will award only individual medals.)**

OMC World Champion Title: The OMC World Champion title is awarded only to senior competitors. Prohibited copying the OMC Team World Cup. If an OMC organization or individual competitor copies the OMC World Cup, OMC will revoke their world champion title and membership. **OMC Miniature World Cup:** Will be awarded to each of the team members starting in 2026.

International Junior Team Rising Star Award (Ages 16 to 23) 1st to 3 Place. Receives the OMC International Junior Team Rising Star Award. The 4th 5th 6th competitor's individual or teams will receive the "OMC Honor Award" All other competitors will receive the "OMC Recognition Award"

Online OMC Europe and Zone Cups: 1st place receives the Cup. All the other 5 will receive the OMC finalist Diplomas. All other participants will receive the OMC Recognition Awards for their courage and perseverance to participate in the championship concerned.

Online OMC Global Artist of the Year Award: 1st place receives the Trophy, all other 5 will receive the OMC finalist Diplomas.

OMC Recognition for Trainers and Jurors: All registered national trainers and jurors receive an OMC Recognition Certificate. Trainers whose team wins the OMC Team World Cup in their category will receive the “OMC World Best Trainer Award” the following year’s Sunday night awards ceremony.

National Trainers Title: OMC recognizes only official national trainers of their national teams. If a trainer from one team trains a team from a different country, they are not considered part of that team and cannot join them on stage if they win.

False Promotion: It is forbidden and disrespectful for any individual who has **not** won the OMC World Cup to promote themselves on social media using an individual photo of the OMC World Cup. If this occurs, it is considered a detrimental act towards OMC. The national organization is responsible for resolving the issue. OMC reserves the right to revoke the national team’s OMC World Cup title and terminate its membership.

Competitor Citizenship and Residency: Who Can You Compete For? You can represent your home country or the country where you live, as long as the country you choose to represent, is an OMC Member.

Competition Cancellation or Rescheduling: OMC reserves the **right to cancel or reschedule** any competition at its sole discretion. If OMC cancels a competition, it will reimburse registration fees. Competitors who cancel after the deadline will not receive a refund.

Competition Rules & Regulations:

Hair Preparation: Before lining up in the holding area, competitors must brush or wet their model/mannequin head hair according to OMC rules.

Mirror Numbers: Competitors’ mirror numbers are distributed in the holding area. Once assigned, competitors will be escorted to their stations by OMC competition directors.

Live Model / Mannequin Dress Code: No signs, logos, designer names, eyeglasses, or cigarettes are permitted. Gents’ clothing must have a masculine look. Violations result in penalties as per the penalty point chart.

Mannequin Presentation: The MH must be set in the middle of the mirrors (OMC rules). If the MH is placed higher than the middle of the mirrors, it will be corrected by the OMC wisemen. All jurors and OMC Wisemen must be able to see the top of the hairstyle. Tools or objects must not be left on the competition table.

OMC Official Mannequin Head Sponsors: Competitors must use mannequin heads from one of the three OMC official sponsors. Additional stickers other than OMC Official sponsor names are prohibited. Non-compliance will result in disqualification.

Electricity & Mirrors: No electric plugs or mirrors are available in the competitor’s preparation area. One plug (max 2000W) per competitor is available on the competition floor. No multiple adapters allowed. Competitors must check the host country’s voltage (220V or 110V) before competing.

ONLINE COMPETITIONS: Please refer to the online photo rules for the exact number of photos required for each category in the Hair, Aesthetics, and Nails sections. It is essential to submit images that clearly display the front/profile, side, and back views for online competitions.

Penalties for Non-Compliance with OMC Rules: Failure to adhere to competition rules will result in penalties imposed by the Committee of Wise Men, according to the penalty point chart in effect. Competitors will be informed of their penalty points via the results list. **Base penalty for rule violations:** 10 points. **Failure to observe “STOP” instructions:** 5 penalty points.

Disqualification Criteria: Competitors may be disqualified under the following circumstances: Use of mannequin heads that are not from OMC official MH Gold Sponsors. Changing assigned mirror numbers with other competitors

OMC NON-COMPETE CLAUSE:

Forbidden to use the OMC Name and TM Logo when Presenting Educational Masterclass.

It is forbidden for member organizations or Sr/Jr. competitors to use the OMC name and or TM logo, when presenting masterclasses for their own personal benefit or for any other entity's benefit. If this is the case, their title and membership will be revoked. They can use only their title to promote their Salon & Personal image. It is strictly forbidden to use any OMC or OMC HAIRWORLD brands without authorization. Any use of OMC combined logos requires prior approval from OMC before printing or posting on social media.

Permitted Usage:

- ✓ National organizations may use combined logos to promote their organization.
- ✓ National organizations may organize national championships using their own logo.
- ✓ Combined logos may be used, as outlined in the OMC Brand Guidelines 2026, but **not as a title**.
- ✓ Organizations, educators or competitors may use their own personal logo when presenting masterclasses or other seminars.

Strictly Forbidden:

- ✗ Organizing international championships for affiliated national organizations.
- ✗ Using the OMC or OMC HAIRWORLD brands/logos individually.
- ✗ Modifying any part of the OMC affiliated member logo.
- ✗ Posting false promotional titles.
- ✗ Participating in competitions not held under the auspices of OMC.
- ✗ Presenting masterclasses using any OMC brands.
- ✗ Issuing diplomas or awards falsely presented as if they were endorsed by OMC.
- ✗ Schools or academies organize competitions using any OMC brands
- ✗ Affiliated organizations presenting masterclasses using OMC brands.
- ✗ Using any images from OMC championships, essential to have written approval.
- ✗ Using OMC Prestige Club image collections, essential to have written approval.
- ✗ It is forbidden for a country organization to register competitors from other countries.

OMC Competition Advisory Board: The OMC advisory board reserves the right to remove any participant or OMC member if they are found to have committed a detrimental act before or during the championship. This ensures fair play to OMC standards, and the preservation of OMC's brand integrity in all competitions.

**New OMC Judging System:
Aesthetics and Nails**

The 30 points will be divided as follows, according to the test:
Each judge must stay fully alert, observe every detail, and evaluate carefully.

This ensures fairness, accuracy, and respect for the new OMC judging system.

Category	Judging Criteria
Aesthetics Bridal Makeup	20 points: Eye symmetry on both eyes and clean lines/blending. 10 points: Final look inspired by OMC guideline
Aesthetics Creative Eyes Makeup	20 points: Symmetry on both eyes with precise lines/blending-clean edges. 10 points: Final look inspired by OMC guideline
Aesthetic Smoky Eyes Makeup	20 points: Even makeup on both eyes with clean, precise lines and smooth blending. 10 points: Final look inspired by OMC guideline
Aesthetic Stage Makeup	20 points: Symmetry on both eyes with precise lines, blending, and edges. 10 points: Final look inspired by OMC guideline
Aesthetic -Fantasy Eyelashes	20 points: Clear fantasy theme with detailed, harmonious design. 10 points: Final look inspired by OMC guideline
Aesthetic Eyebrows Shaping & Tinting	20 points: Symmetrical eyebrows with precise lines and natural blending. 10 points: Final look inspired by OMC guideline
Nails Salon Manicure Design	20 points: Precision of the manicure and harmony of the nail design. 10 points: Final look inspired by OMC guideline
Nails Nail Painting in Box	20 points: For detailed nail artwork that maintains harmony and elegance. 10 points: Final look inspired by OMC guideline.
Nails Full Fantasy Nails Look	20 points: Clear fantasy theme with detailed, harmonious, and elegant nail artwork 10 points: Final look inspired by OMC guideline

Aesthetic “Glam & Art Cup” - Test 1. Bridal Makeup LM

Labor safety rules and hygiene requirements must be observed.

The competitors will proceed with their models to their assigned working stations, guided by the OMC Competition Director to the correct mirror number. The competitors have 5 minutes to prepare their products and makeup brushes at their assigned station. After control of the assigned mirror the competitors will be addressed to wait on the red carpet, and the Competition Directors will check if the model is presented according to the rules. Otherwise, penalty points will be applied.

In Subject: Bridal Make-Up is simple and commercial in nature, reflecting the current fashion trends, and inspired by OMC Inspirations.

Clothing and Hair: The models can be beautifully dressed and have their Bridal Style prepared in advance.

Face Preparation: The competitors may choose to prepare their model's face base in advance, including corrector, base foundation, contouring and shaped eyebrows. All the rest of the makeup must be applied during the test (e.g., false or extended eyelashes, lips makeup, eye makeup, etc.).

Colors: All the palette's colors, eye pencils, lipsticks, and lip pencils are allowed and free to choose if the final effect is natural and elegant.

Eyelashes: False individual strand or multiple eyelashes are allowed.

Eyes Design: The design must be maintained inside the circle of the eyes.

Time: 35 minutes.

Scores: Maximum 30 points / Minimum 24 points.

x. Off Subject: Onsite - Online

Online Pictures: Must upload (1) frontal-view photos showing the full face: **(1) with closed eyes.**

Online Background: Suggested black or white.

Online Photo Retouching: Allowed up to 10% maximum.

x. Forbidden: Profile photos are not allowed.

x. Forbidden: Artistic or dramatic contact lenses are not allowed; only natural-looking lenses are permitted.

x. Forbidden: Mirror or flip retouching is forbidden.

x. Forbidden: Designs outside the circle of the eye and above the eyebrow/forehead. The face must remain clean and free of decorative elements, lines or any elements outside the eye zone.

x. Penalty Points: 10 Points.

The competitors will proceed with their models to their assigned working stations, guided by the OMC Competition Director to the correct mirror number. The competitors have 5 minutes to prepare their products and makeup brushes at their assigned station. After control of the assigned mirror the competitors will be addressed to wait on the red carpet, and the Competition Directors will check if the model is presented according to the rules. Otherwise, penalty points will be applied.

In Subject: Creative Eyes Makeup presents a creative eye design. It is recommended that the chosen colors and shading are combined harmoniously, maintaining elegance and overall balance, while staying within the circle of the eye area. The Creative Eyes Makeup reflects the current fashion trends and inspired by OMC Inspirations.

Clothing and Hair: The models can be beautifully dressed and have their Hairstyle prepared in advance.

Face Preparation: The competitors may choose to prepare their model's face base in advance, including corrector, base foundation, contouring and shaped eyebrows. All the rest of the makeup must be applied during the test (e.g., false or extended eyelashes, lips makeup, eye makeup, etc.).

Colors: All palette colors, eye pencils, lipsticks, and lip pencils are allowed and free to choose. The chosen colors should be combined harmoniously and perfectly integrated into the overall makeup.

Eyelashes: False individual strand or multiple eyelashes are allowed.

Eyes Design: The design must be maintained inside the circle of the eyes.

Time: 35 minutes.

Scores: Maximum 30 points / Minimum 24 points.

x. Off Subject: Onsite - Online

Online Pictures: Must upload two (1) frontal-view photos showing the full face: **(1) with closed eyes.**

Labor safety rules and hygiene requirements must be observed.

The competitors must create an online photo work in the Smoky Eyes Makeup category. The photos must show the model's full face, be clear, and be well-lit. The background must be plain white or black, without any distracting elements, and the lighting must be natural or studio, evenly distributed.

In Subject: Smoky Eyes Makeup must be classic and commercial in style, reflecting current beauty and fashion trends. The design should have perfectly blended colors and shading, demonstrating harmony, depth, and professional technique, while staying within the circle of the eye. The final result should appear elegant, refined, and wearable. The Smoky Eyes Makeup should be inspired by OMC Inspirations.

Clothing and Hair: The model's clothing and hairstyle must be consistent with the aesthetic required for the category (see OMC inspiration examples).

Face Preparation: The competitors may choose to prepare their model's face base in advance, including corrector, base foundation, contouring and shaped eyebrows. All the rest of the makeup must be applied during the test (e.g., false or extended eyelashes, lips makeup, eye makeup, etc.).

Colors: Only natural and dark tones are allowed. Bright, colorful, or creative shades are not permitted.

Eyelashes: False individual strand or multiple eyelashes are allowed.

Eyes Design: The design must be maintained inside the circle of the eyes.

Time: 35 minutes.

Scores: Maximum 30 points / Minimum 24 points.

x. Off Subject: Onside - Online

Online Pictures: Must upload two (1) frontal-view photos showing the full face: **(1) with closed eyes**.

Online Background: Suggested black or white.

Online Photo Retouching: Allowed up to 10% maximum.

x. Forbidden: Profile photos are not allowed.

x. Forbidden: Artistic or dramatic contact lenses are not allowed; only natural-looking lenses are permitted.

x. Forbidden: Mirror or flip retouching is forbidden.

x. Forbidden: Designs outside the circle of the eye and above the eyebrow/forehead. The face must remain clean and free of decorative elements, lines or any elements outside the eye zone.

x. Forbidden: Use of colorful or fantasy eyeshadows is not allowed.

x. Penalty Points: 10 Points.



Aesthetic “Individual” - Stage Makeup LM

Labor safety rules and hygiene requirements must be observed.

The competitors must create an online photocopy in the Stage Makeup category. The photos must show the model's full face, be clear, and be well-lit. The background must be plain white or black, without any distracting elements, and the lighting must be natural or studio, evenly distributed.

In Subject: Demonstration of creativity, precision, and a high level of artistry in creating a complete inspiration image. Makeup must be performed in stage style, with a strong artistic accent and clearly structured form. The design should extend beyond the eye area, adding dimension and connecting with the creative eyelid design to highlight the artistic concept inspired by OMC Inspirations.

Clothing and Hair: The model's clothing and hairstyle must be consistent with the aesthetic required for the category (see OMC inspiration examples).

Colors: All palette colors, eye pencils, lipsticks, and lip pencils are allowed and free to choose. The chosen colors should be combined harmoniously and perfectly integrated into the overall makeup.

Eyelashes: False individual strand or multiple eyelashes are allowed.

Eyes Design: The eye design must remain within the expected stage style. It should be aesthetic, balanced, and harmonious, maintaining a look that is appropriate for the required style. Exceeding the limits of the stage image is not allowed.

Decorations: Decorative elements (rhinestones, glitter or other decoration) are allowed if they correspond to the inspirational image concept.

Scores: Maximum 30 points / Minimum 24 points.

x. Off Subject: Online

Online Pictures: Must upload two (1) frontal-view photos showing the full face: **(1) with closed eyes.**

Online Background: Suggested black or white, plain, without any distracting elements.

Online Photo Retouching: Allowed up to 10% maximum.

x. Forbidden: Profile photos are not allowed.

x. Forbidden: Artistic or dramatic contact lenses are not allowed; only natural-looking lenses are permitted.

Aesthetic "Individual" - Fantasy Eye Lashes LM

Labor safety rules and hygiene requirements must be observed.

The competitors must create online photo work in the Fantasy Eye Lashes category. The photos must show the model's full face, be clear, and be well-lit. The background must be plain white or black, without any distracting elements, and the lighting must be natural or studio, evenly distributed.

In Subject: Demonstration of creativity, cleanliness, and technical excellence in working with fantasy eyelashes. The makeup should combine color, shape, and decoration, highlighting the artist's aesthetic sense. The work should follow the style of Stage Makeup and Creative Eye Makeup, incorporating a fantasy element made from lashes and decorative materials to emphasize the concept. The Fantasy Eye Lashes and the model's look should be inspired by OMC Inspirations.

Clothing and Hair: The model's clothing and hairstyle must be consistent with the aesthetic required for the category (see OMC inspiration examples).

Colors: All palette colors, eye pencils, lipsticks, and lip pencils are allowed and free to choose. The chosen colors should be combined harmoniously and perfectly integrated into the overall makeup.

Eyelashes: Fantasy eyelashes may be handmade, using lashes and decorative elements like rhinestones, feathers, glitter, ribbons, beads, and colored materials. All elements must be securely attached, safe, and not interfere with opening or closing the eyes. The final result should be artistic, refined, and harmonious.

Eyes Design: The eye design must remain within the expected stage style. It should be aesthetic, balanced, and harmonious, maintaining a look that is appropriate for the required style. Exceeding the limits of the stage image is not allowed.

Decorations: Decorative elements (rhinestones, glitter or other decoration) are allowed if they correspond to the inspiration image concept.

Scores: Maximum 30 points / Minimum 24 points.

x. Off Subject: Online

Online Pictures: Must upload two (1) frontal-view photos showing the full face: **(1) with closed eyes**.

Online Background: Suggested black or white, plain, without any distracting elements.

Online Photo Retouching: Allowed up to 10% maximum.

x. Forbidden: Profile photos are not allowed.

x. Forbidden: Artistic or dramatic contact lenses are not allowed; only natural-looking lenses are permitted.

x. Forbidden: Mirror or flip retouching is forbidden.

x. Forbidden: Use of props, masks, or decorative backgrounds.

x. Penalty Points: 10 Points.



Aesthetic “Individual” - Eyebrows Shaping & Tinting LM

Labor safety rules and hygiene requirements must be observed.

The competitors must create online photo work in the Eyebrows Shaping & Tinting category. The photos must show the model's full face, be clear, and be well-lit. The background must be plain white, without any distracting elements, and the lighting must be natural or studio, evenly distributed.

In Subject: The work must demonstrate cleanliness, symmetry, shape, and harmony in the eyebrow design, considering the model's individual facial features.

Tinting: should be done using a professional eyebrow dye to preserve a soft, natural effect with smooth color transitions.

The complete look must be neat, balanced, symmetrical, and harmonious, emphasizing the individuality of the model. The eyebrow shaping & tinting, as well as the model's overall look, should be inspired by OMC Inspirations.

Clothing: The model must wear a plain white T-shirt without prints or logos.

Hairstyle: The model's hair must be neatly tied into a ponytail or chignon.

Makeup: Light makeup is allowed: foundation, light contour, and mascara on eyelashes. Any other type of bold or conspicuous makeup is not permitted.

Eyelashes: Only a natural eyelash look is allowed, with no visible artificial effects.

Eyes Design: The eye design must remain within the expected stage style. It should be aesthetic, balanced, and harmonious, maintaining a look that is appropriate for the required style. Exceeding the limits of the stage image is not allowed.

Decorations: Decorative elements (rhinestones, glitter or other decoration) are allowed if they correspond to the stage image concept.

Scores: Maximum 30 points / Minimum 24 points.

x. Off Subject: Online

Online Pictures: Must upload two (1) frontal-view photos showing the full face: **(1) with finished result**.

Online Background: Suggested white, plain, without any distracting elements.

Online Photo Retouching: It is forbidden to add digital elements or to artificially enhance the tint intensity.

x. Forbidden: Profile photos are not allowed.

x. Forbidden: Artistic or dramatic contact lenses are not allowed; only natural-looking lenses are permitted.

x. Forbidden: Mirror or flip retouching is forbidden.

Lighting may be natural or studio and must be evenly distributed.

In Subject: Demonstration of creativity, cleanliness, and technical excellence in professional nail design. The manicure must be very clean, with even and balanced design, including creative elements and simple, elegant decorations, showing the artist's style. The nail design and the model's hand overall presentation should be inspired by OMC Inspirations.

Decorations: Decorations can be hand-painted, applied, or use professional nail embellishments, such as glitter, stencils, painted designs, or small nail embellishments. This choice must remain in harmony with the overall design, making it elegant and wearable, without covering the entire nail.
